- (a) operate the rodeo in accordance with the conditions contained in the licence: and
- (b) provide conditions and facilities for animals at the rodeo which conform to the conditions contained in the licence

I further declare that I will notify the Departmental Head at least 28 days before the rodeo is operated under this licence of --

- (c) the date or dates that the rodeo will be held;
- (d) the start and finish times for each day of the rodeo;
- (e) the precise location where the rodeo will be held;
- (f) the full name of the nominated veterinary practitioner attending the rodeo;
- (g) the full street or postal address of the nominated veterinary practitioner attending the rodeo;
- (h) the contact phone numbers of the nominated veterinary practitioner attending the rodeo; and
- (i) a list of all rodeo events to be held at the rodeo.
